5 nothing whatsoever to do with this case that with your
6 permission I would like to do right now.

7 And that is, because this is an antitrust case, I
8 would like to state on the record that yesterday the antitrust
9 bar and the United States lost one of its most important people
10 in Thomas Rosch, the former Federal Trade Commissioner, former
11 chair of the ABA antitrust section, and to me, my mentor and
12 partner for some 30 years.

13 Commissioner Rosch had appeared in hundreds of
14 antitrust lawsuits all over this country for 40 years and was
15 always a favorite of judges. He was somebody who was Nebraska
16 raised and was just as honest as the day is long and a
17 real student of antitrust and a real credit to everything that
18 lawyers hold dear.

19 I learned at 11 o'clock last night that he had passed
20 away, and I just think it's right that on a record in an
21 antitrust case on this day, there is a mention of J. Thomas
22 Rosch.

23 THE COURT: Well, thank you.

24 MR. WALL: Thank you, Your Honor.
