Commissioner Rosch had appeared in hundreds of antitrust lawsuits all over this country for 40 years and was always a favorite of judges. He was somebody who was Nebraska raised and was just as honest as the day is long and a real student of antitrust and a real credit to everything that lawyers hold dear.

I learned at 11 o'clock last night that he had passed away, and I just think it's right that on a record in an antitrust case on this day, there is a mention of J. Thomas Rosch.
