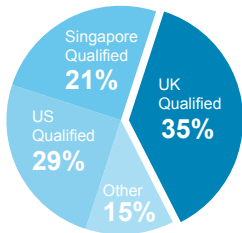

## SUMMER VACATION SCHEME

- A benefits package that includes life assurance, medical and dental assurance, and 20 days' paid holiday per year.

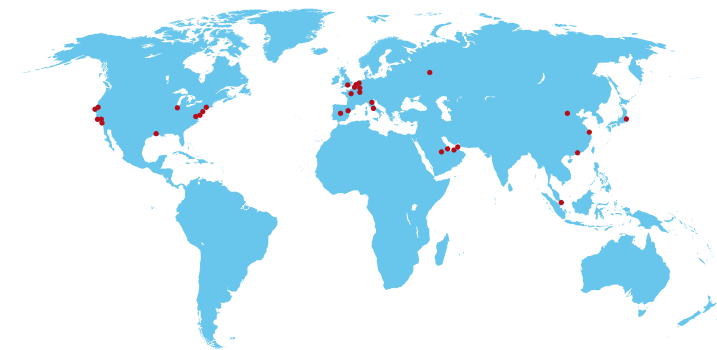
