

Latham Snags Ex-Fish & Richardson Patent Atty In DC

Latham & Watkins LLP has hired a Fish & Richardson PC patent litigator to join the firm's Washington, D.C., office after he successfully represented top technology and chemical companies as lead counsel in high-profile patent infringement disputes, Latham & Watkins said Tuesday.

Wheeler has an undergraduate degree in electrical engineering from the University of Maryland and a law degree from George Washington University Law School.

Michael Egge, the firm's office managing partner in Washington, D.C., said Tuesday that Wheeler is a dynamic litigator who embodies the "innovative, insightful counsel" the firm offers its clients.
