Latham Lures West Coast-Bound White-Collar Partner From Paul Weiss

His practice focuses on white-collar and regulatory defense matters and investigations for major global and Japanese companies and financial institutions, according to the firm.

He previously represented a Japanese financial institution in parallel federal and state regulatory proceedings in the U.S.; a Japanese conglomerate and its U.S. subsidiary in a fraud investigation conducted by the U.S. Attorney's Office for the Central District of California; and a Korean semiconductor company in a U.S. Securities and Exchange Commission investigation related to accounting issues, among other matters.

Before his private practice, Frey served as an assistant U.S. attorney for the Southern District of New York for over seven years, where he focused on commodities fraud and cybercrimes, among other matters. He was also an associate counsel for the White House Counsel's Office under President Barack Obama for about a year.

on connections between Latham's current offerings and my experience in Japan, while also contributing to the white collar group from New York to California to Asia and beyond," Frey said in a statement at the time of the announcement.

Frey joins Latham as it continues to enhance its white-collar defense team around the world.

In January, the firm added former prosecutors Scott Joiner and Alex Wyman in San Francisco and Los Angeles, respectively. Joiner spent seven years as an assistant U.S. attorney for the Northern District of California, while Wyman served as an assistant U.S. attorney for the Central District of California for about five years.
