# DEALMAKERS OF THE YEAR FINALIST

Sarah Axtell, Rick Kline and Tony Richmond, Latham & Watkins

Sarah Axtell and Rick Kline, partners, and Tony Richmond, retired partner, at Latham & Watkins are among the finalists for The Recorder's 2025 Dealmakers of the Year Award. Read a Q&A with them below.

### What are some of your most significant achievements of the past year?

Sarah Axtell: Beyond working with the team to advise on Reddit's \$748 million IPO—the first social media IPO in five years—I'm proud of working on nearly every notable tech IPO of 2024. My work of the past year includes venture-backed IPOs for Rubrik (who I have worked with since the company's early stages, first advising on their incorporation in 2018) and ServiceTitan, as well as OneStream's IPO. Those all contributed

to the revival of the tech IPO market, which had previously lay dormant the past few years. I've also enjoyed the strides I've made in redomiciling, and establishing a successful model for tech companies considering reincorporation through my work advising The Trade Desk on its reincorporation to Nevada.
