2023 M&A Texas Deal-Lawyer Rankings

The Corporate Deal Tracker's Texas lawyer rankings for M&A dealmaking in 2023 ranked by deal count from Jan. 1 through Aug. 31 shows that only two lawyers have been involved in at least 10 mergers, acquisitions and joint ventures so far this year, but 23 have worked on five or more transactions during the first eight months of the year. These are lawyers based in Texas who represented any client (buyers, sellers, targets, financial advisors, banks, conflict committees or third parties).

Latham & Watkins partner Ryan Maierson of Houston has worked on 13 deals with a combined value of \$25.1 billion. Katten partner Victor Zanetti of Dallas handled 10 transactions. All of Zanetti's involved privatelyheld companies in which the value of the deal was confidential.

Kirkland & Ellis placed 11 lawyers in the CDT's top 20 and 20 of the top 50. Latham has seven of the top 50 and Sidley has six.
